Object of the society

The object of The Literary London Society is the advancement of research, scholarship, and public education, in particular, by the promotion of the study of the literature and cultural history of London.

Principal activities

In furtherance of its objectives the Society engaged in the following main activities during the year:

- 1 Produced further editions of its journal;
- 2 Held a conference in London in July 2017;
- 3 Held full committee meetings and arranged for the 2018 conference in London;
- 4 Held regular postgraduate reading group meetings throughout the year.

The executive committee has had regard to the Charity Commission guidance on public benefit when considering its objectives.

Review of activities and financial position

The executive committee was pleased with the activities arranged and managed by the Society during the year, and consider that the society is developing well. This is the second full financial year of the society in which the society opened an account with the Co-operative Bank. In this financial year, the Society received membership subscriptions of £991.79 (net after PayPal charges) and gave awards and prizes to the value of £426.00.

The movement in funds for the year is set out in the statement of financial activities on page 8.

The Society's unrestricted reserves at 30 June 2018 amounted to £4522.45. There were no restricted reserves, making total reserves of £4522.45.

There were 61 paid-up members of the Society at 30 June 2018. (79 at 30 June 2017)

Independent Examiner's report to the Executive Committee of the Literary London Society

I report on the financial statements of the Society for the year ended 30 June 2017 which are set out on pages 5 to 9.

Respective responsibilities of executive committee

The Society's executive committee is responsible for the preparation of the financial statements. Because the Society's income was below £25,000 in this financial year, it considers that an audit is not required for the year under section 144(2) of the Charities Act 2011 (the Act), nor that a formal independent examination is required under section 145(1) of the Act. For good practice, however, the Society has asked for an independent person to examine the accounts.

It is my responsibility to:

- Examine the financial statements under section 145 of the Act;
- Follow the procedures laid down in the General Directions given by the Charity Commission under section 145(5)(b) of the Act; and
- State whether particular matters have come to my attention.

Basis of independent examiner's report

My examination was carried out in accordance with the General Directions given by the Charity Commission. An examination includes a review of the accounting records kept by the Charity and a comparison of the financial statements presented with those records. It also includes consideration of any unusual items or disclosures in the financial statements, and seeking explanations from you as the executive committee concerning such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the financial statements present a 'true and fair view' and the report is limited to those matters set out in the statement below.

Independent examiner's statement

In connection with my examination, no matter has come to my attention:

(1) which gives me reasonable cause to believe that in any material respect the requirements:

- to keep accounting records in accordance with section 130 of the Act; and

Notes to the financial statement for the year ended 30 June 2018

1) Accounting policies

The financial statements have been prepared under the historical cost convention and in accordance with applicable accounting standards and the Statement of Recommended Practice on accounting by Charities.

Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the objectives of the Society. The Society does not currently hold any restricted funds.

Incoming resources

Subscriptions are credited to the statement of financial activities in the financial year in which they are received.

Resources expended

Resources expended are recorded on an accruals basis.

2) Sundry expenses

Sundry expenses per the statement of financial activities consist primarily of committee meeting expenses and the reimbursement of the committee members' travelling/administrative expenses incurred in representing the Society.

During the year 0 committee members received remuneration of Nil. No expenses were reimbursed to officers of the society (2017: £198.00) (2016: £211.70) (2015: 181.60) (2014: £134.30) (2013: £261.60).
